## REQUIREMENTS OF ALL APPLICANTS FOR THE MASTER ELECTRICIAN LICENSE EXAM FOR THE CITY OF BINGHAMTON

1. You must hold a journeyman's electrician's license. **Provide a copy of your current license.**
2. If you are partner or an officer of a current electrical contracting business please list the names and addresses of all officers or members of the firm or corporation. Underline the name of the person taking the examination.
3. You must provide the years of experience you have in the electrical business and in what capacity. A minimum of **TWO YEARS experience as a Licensed Journeyman Electrician is required.**
4. Accompanying your **completed** Master Electrician application form, you must provide documentation of the name and the address of your current employer.
5. You must submit the application, employment letter and a check or money order made out to the **City of Binghamton** for \$150.00. **Applications will not be accepted without a check or money order.** If your application is rejected for any reason, the check or money order will be returned with a letter stating the reason for denial.
6. The required application, check or money order and all supporting documentation must be delivered to the City of Binghamton Office of Buildings and Construction, 38 Hawley Street, Binghamton, New York 13901 by the last day of the month, 2 months **prior** to the exam. Applications submitted after this date will be held over until the next available examination date. You will be notified in writing that you are ineligible to take the current exam.
7. Master examinations are given once in January, May and September of each year **on the third Saturday of the month**, unless there are not enough applicants to take the exam.
