AN ORDINANCE AUTHORIZING A
TRANSFER IN THE COMMUNITY
DEVELOPMENT BLOCK GRANT FY 37
BUDGET, AND AUTHORIZING AN INCREASE
OF UP TO \$10,000 IN CONTRACTUAL
EXPENSES WITH INTERFACE STUDIO

WHEREAS, the Director of Planning, Housing and Community Development finds it proper and necessary to transfer funds in the Community Development Block Grant (CDBG) FY 37 budget and to enter into a supplemental agreement with Interface Studio for the City's comprehensive plan for an amount not to exceed \$10,000; and

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:


Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to amend FY 37 CDGB budget, transferring \$10,000 from budget line CD8684.51000 (Personal Services) to budget line CD8684.54000.CDY37 (Contractual), pending approval by the Board of Estimate and Apportionment.

Section 2. That the Mayor, or his designee, is hereby authorized to enter into a supplemental agreement, approved as to form and content by the Office of Corporation Counsel, with Interface Studio for the City's comprehensive plan, in an additional amount not to exceed \$10,000.
