AN ORDINANCE AUTHORIZING THE  
REASSIGNMENT OF BONDED FUNDS FOR  
THE CITY HALL ELEVATOR PROJECT

WHEREAS, the Council of the City of Binghamton adopted Permanent Ordinance 09-15 on May 18, 2009, entitled, "An Ordinance authorizing the issuance of \$8,262,428 in Serial Bonds to Finance Various City Projects"; and

WHEREAS, the City of Binghamton wishes to reassign bonded funds that were unspent from the Emergency Generator Project to the City Hall Elevator Project, transferring \$40,000 from budget line H1620.525107.51809 (City Hall --Emergency Generator) to budget line H1620.525002.51809 (City Hall -- Elevators); and

WHEREAS, the budget transfer was approved by the Board of Estimate and Apportionment on June 12, 2013.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:


Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to transfer \$40,000 from budget line H1620.525107.51809 (City Hall -- Emergency Generator) to budget line H1620.525002.51809 (City Hall -- Elevators).

Section 2. That this Ordinance shall take effect immediately.
