WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to establish new budget lines in the 2013 Economic Development budget for Travel & Training and to transfer funds thereto; and

WHEREAS, the Council of the City of Binghamton approves this amendment to the budget.


NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to establish budget line A6989.54701 (Travel & Training) in the 2013 Economic Development budget.


Section 2. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to transfer \$1,500.00 from budget line A7020.51000 (Parks & Recreation [Personal Services]) to budget line A6989.54701 (Travel & Training).

Section 3. That this Ordinance shall take effect immediately.
