AN ORDINANCE AUTHORIZING A
TRANSFER IN THE 2013 PHASE III REMEDIAL
PROJECT BUDGET FOR PROFESSIONAL
SERVICES AT THE BINGHAMTON-JOHNSON
CITY JOINT SEWAGE TREATMENT PLANT

WHEREAS, the City of Binghamton (the "City") is a joint owner of the Binghamton-Johnson City Joint Sewage Treatment Plant (the "JSTP") with the Village of Johnson City (the "Village"); and

WHEREAS, the City and Village entered into Intermunicipal Agreement No. VIII designating the City as "Lead Agency" for the Phase III Remedial Project; and

WHEREAS, the City Engineer finds it proper and necessary to transfer funds within the 2013 Phase III Remedial Project budget for the purpose of funding additional design work of a new DAF Facility, standby generators, scum collector, construction management of the advance demolition project and additional destructive/nondestructive testing; and

WHEREAS, this budget transfer was approved by the Board of Estimate and Apportionment on August 7, 2013; and


WHEREAS, the Council of the City of Binghamton wishes to approve this transfer.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to transfer \$1,610,000.00 from budget line HX8150.500100.J11FF (Professional Services, Flood) to budget line HX8150.500100.J11NN (Professional Services, Non-Flood).

Section 2. That this Ordinance shall take effect immediately.

I HEREBY CERTIFY that the above described funds are unencumbered and available.
