AN ORDINANCE AMENDING THE 2012 RISK MANAGEMENT BUDGET TO TRANSFER \$18,934.85 FROM BUDGET LINE M1910.54900 (INCURRED LOSS), \$14,513.70 FROM BUDGET LINE M1910.54754 (EMERGENCY SAFETY), AND \$11,294.67 FROM BUDGET LINE M1910.54300 (INSURANCE) TO BUDGET LINE M1910.54430 (LEGAL SERVICES)

WHEREAS, Corporation Counsel finds it proper and necessary to transfer funds within the 2012 Risk Management budget for legal services; and

WHEREAS, the Council of the City of Binghamton wishes to approve this amendment to the 2012 budget.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:


Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2012 Risk Management budget transferring \$18,934.85 from budget line M1910.54900 (Incurred Loss), \$14,513.70 from budget line M1910.54754 (Emergency Safety), and \$11,294.67 from budget line M1910.54300 (Insurance) to budget line M1910.54430 (Legal Services)

Section 2. That this Ordinance shall take effect immediately.
