AN ORDINANCE ESTABLISHING A
PROFESSIONAL SERVICES BUDGET LINE IN
THE 2013 CITY COUNCIL BUDGET AND
TRANSFERRING FUNDS THERETO TO
COVER THE COST OF TRANSLATION
SERVICES FOR PUBLIC MEETINGS

WHEREAS, the City Clerk has recommended an amendment to the 2013 City Council budget to establish and fund a Professional Services budget line to cover the cost of translation and/or interpretation services for individuals requiring such services during public meetings; and

WHEREAS, funds are currently available in budget line A1410.54101 (City Clerk—Office Supplies) for this purpose.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to establish budget line A1010.54410 (City Council—Professional Services) in the 2013 City Council budget.


Section 2. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to transfer \$200.00 from budget line A1410.54101 (City Clerk—Office Supplies) to budget line A1010.54410 (City Council—Professional Services).

Section 3. That this Ordinance shall take effect immediately.
