AN ORDINANCE AUTHORIZING VARIOUS  
TRANSFERS IN THE DEPARTMENT OF  
INFORMATION MANAGEMENT &  
TECHNOLOGY 2013 BUDGET

WHEREAS, the Finance Data Processing Operations Coordinator finds it proper and necessary to transfer funds within the 2013 Information Management & Technology budget for replacement and repair of security doors as well as replacement of office furniture; and

WHEREAS, the Finance Data Processing Operations Coordinator also requests that budget line A1680.52200 (Furniture) be established in the 2013 Information Management & Technology Department budget; and

WHEREAS, the budget transfers were approved by the Board of Estimate and Apportionment on November 13, 2013; and

WHEREAS, the Council of the City of Binghamton wishes to approve the transfers and to establish budget line A1680.52200 (Furniture) in the 2013 Information Management & Technology Budget.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2013 Information Management & Technology budget to establish budget line A1680.52200 (Furniture) and transfer \$12,000 from budget line 1680.51800 (Temporary Services) thereto.

Section 2. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2013 Information Management & Technology budget to transfer \$18,000 from budget line A1680.51800 (Temporary Services) to budget line A1680.54610 (Building/Equipment Repair & Maint.).

Section 3. That this Ordinance shall take effect immediately.
