AN ORDINANCE AUTHORIZING THE  
TRANSFER OF \$7,693 FROM BUDGET LINE

LINE A1364.54682 (PURCHASE OF REAL  
PROPERTY)

WHEREAS, the Director of Planning, Housing and Community Development finds it proper and necessary to transfer funds within the 2014 budget to purchase foreclosed flood-damaged properties; and

WHEREAS, the budget transfer was approved by the Board of Estimate and Apportionment on May 7, 2014; and

WHEREAS, the Council of the City of Binghamton wishes to approve the transfer.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to transfer \$7,693.00 from budget line A1364.54681 (In Rem Taxes) to budget line A1364.54682 (Purchase of Real Property) to purchase foreclosed flood-damaged properties located at 510.5 Chenango Street, 12 Gaines Street, 5 Valley Street, and 11 Baltimore Avenue.
