AN ORDINANCE AUTHORIZING THE
TRANSFER OF VARIOUS FUNDS WITHIN THE
2014 BUDGET TO COVER THE COST OF GAS
AND ELECTRICITY AT THE FIRST WARD
SENIOR CENTER

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to transfer funds within the 2014 First Ward Senior Center budget to cover cost of gas and electricity; and

WHEREAS, the proposed budget transfer was approved by the Board of Estimate and Apportionment on July 16, 2014.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2014 First Ward Senior Center budget transferring \$3,000 from budget line A1990.55010 (Utility Contingency) to budget line A7620.54201 (Senior Center Gas) and \$7,000 from A1990.55010 (Utility Contingency) to budget line A7620.54202 (Senior Center Electric).

Section 2. That this Ordinance shall take effect immediately.
