**AN ORDINANCE AMENDING THE FEE FOR
POLICE AND FIREFIGHTER CIVIL SERVICE
EXAMINATIONS**

WHEREAS, in accordance with Civil Service Law §50.5(b), the Civil Service Commission, with the approval of the legislative body of such city, to establish a uniform schedule of reasonable fees for Civil Service examinations; and

WHEREAS, the Council of the City of Binghamton last amended the Police and Firefighter Civil Service Exam fee schedule on June 5, 2000 through the adoption of Permanent Ordinance 00-52, entitled "An Ordinance Authorizing the Municipal Civil Service Commission to Modify the Civil Service Examination Fee Schedules for the City of Binghamton"; and

WHEREAS, the Director of Personnel and Employee Safety has recommended an amendment to the fee schedule for the Police and Firefighter Civil Service examinations; and

WHEREAS, the Council of the City of Binghamton wishes to adopt the proposed fee schedule for the Police and Firefighter Civil Service Examinations.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the City of Binghamton does hereby adopt the following fee schedule for the Police and Firefighter Civil Service Examinations:

Police and Firefighter Civil Service Exam	\$25

Section 2. That this Ordinance shall take effect immediately.
