AN ORDINANCE AMENDING THE 2014 CAPITAL BUDGET (ROSS PARK AMPHITHEATER) ADDING REVENUE LINE H43089.EG001 (STATE AID PARKS) AND EXPENSE LINE H1440.555555.EG01-ROSS PARK AMPHITHEATER) IN THE AMOUNT OF \$370,000

WHEREAS, the Council of the City of Binghamton adopted Permanent Resolution 11-2 on January 5, 2011, entitled "A Resolution Authorizing the Mayor to Submit an Application and Accept Funds from the NYS Office of Parks, Recreation and Historic Preservation for the Design and Reconstruction of the Ross Park Amphitheatre" for up to \$600,000; and

WHEREAS, based on actual cost estimates, the anticipated grant reimbursement will be up to \$370,000; and


WHEREAS, the Comptroller finds it proper and necessary to amend the 2014 Capital Budget to create revenue and expense lines, each in the amount of up to \$370,000, for this purpose.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows

Section 1. That the Comptroller of the City of Binghamton is hereby authorized and directed to create revenue line H43089.EG001 (State Aid Parks) and expense line H1440.555555.EG01-Ross Park Amphitheater) in the amount of \$370,000; this amount may be decreased based on actual costs.

Section 2. That this ordinance shall take effect immediately.
