**A ORDINANCE TO ESTABLISH BUDGET LINE
A1440.54455 (STREET REPAIRS) IN THE 2014
BUDGET AND MAKING VARIOUS
TRANSFERS TO FUND SAID BUDGET LINE**

WHEREAS, the Commissioner of Public Works requests to establish and fund a new budget line in the 2014 Department of Public Works budget for street repairs; and

WHEREAS, the Comptroller of the City of Binghamton wishes to amend the 2014, transferring funds from various department to fund the new budget line for street repairs; and

WHEREAS, the proposed budget transfers was approved by the Board of Estimate and Apportionment on October 8, 2014; and

WHEREAS, the Council of the City of Binghamton wishes to approve the transfers.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to establish budget line A1440.54455 (Street Repairs) in the 2014 Department of Public Works budget.

Section 2. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2014 budget for street repairs, transferring such funds as follows:


