WHEREAS, Corporation Counsel finds it proper and necessary to transfer funds within the 2014 Risk Management budget for legal services; and


WHEREAS, the proposed budget transfer was approved by the Board of Estimate and Apportionment on September 17, 2014.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2014 Risk Management budget transferring \$30,000 from budget line M1910.54900 (Provision for Incurred Loss) to budget line M1910.54430 (Legal Services).


Section 2. That this Ordinance shall take effect immediately.
