AN ORDINANCE AUTHORIZING A REVISION
TO THE 2013 CAPITAL BUDGET

WHEREAS, the Council of the City of Binghamton adopted Permanent Ordinance 13-82 on November 20, 2013, entitled "An Ordinance Adopting the Tax Budget for the Year 2013", which legislation included the 2013 Capital Improvements Plan Budget ("2013 Capital Budget"); and

WHEREAS, the Commissioner of Public Works has recommended a revision to the 2013 Capital Budget.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized to amend the 2013 Capital Budget as follows:

Remove

DPW	Electrician Support Vehicle	\$50,000
DPW	Transfer Trailer	\$70,000

Add

DPW	John Deere 624 Front End Loader	\$166,667.45
-----	---------------------------------	--------------

Section 2. That the balance of the lease price for the John Deere 624 Front End Loader of \$46,776.45 will be paid from other 2013 capital lease underruns.

Section 3. That this Ordinance shall take effect immediately upon its approval by the Board of Estimate and Apportionment of the City of Binghamton.
