ORDINANCE

AN ORDINANCE AMENDING CHAPTER 124,  
ARTICLE VIII OF THE CODE OF THE CITY OF  
BINGHAMTON, REGARDING OFFICERS AND  
EMPLOYEES NOT COVERED BY  
COLLECTIVE BARGAINING AGREEMENTS

WHEREAS, Chapter 124 of the Code of the City of Binghamton, Article VIII *Officers and Employees not covered by collective bargaining agreements*, requires periodic review and updates; and

WHEREAS, City Council wishes to amend certain sections of this Article as provided herein.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That Article VIII *Officers and Employees not covered by collective bargaining agreements*, is amended as follows:

Section 124-39, *Definitions*, 1. The positions (elected and management appointed): Delete the titles "Chief Information Officer" and "Water and Sewer Superintendent." Add the titles "Commissioner of Parks" and "Assistant City Engineer."

Section 124-39, *Definitions*, 2. The positions (management tested): Delete the titles "Civil Service Administrator," "Director of Parks & Recreation" and "Director of Youth Bureau." Add the titles "Water and Sewer Superintendent," "Youth Success Initiative Director," and "Assistant Director of Public Housing & Community Development."

Section 124-39. A, *Standard work day*, Delete "Chief Information Officer."

Section 124-40, *Salary increases*: delete subsection C.(2).

To the extent titles, sections, or paragraphs are amended herein, related sections or paragraphs will be re-numbered or letters re-assigned by the City Clerk as necessary. Except as amended or re-ordered as provided herein, other sections shall continue in full force and effect.

Section 2. That this ordinance shall take effect on January 1, 2015.
