**AN ORDINANCE AUTHORIZING A BUDGET
AMENDMENT TO PAY FOR GRANT
CONSULTING SERVICES**

WHEREAS, the Executive Assistant to the Mayor finds it proper and necessary to amend the 2015 budget, transferring \$55,000 from various departments to pay for grant consulting services; and

WHEREAS the proposed budget transfers were approved by the Board of Estimate and Apportionment on March 4, 2015; and

WHEREAS, the Council of the City of Binghamton wishes to approve the transfers.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2015 budget to pay for grant consulting services, transferring such funds as follows:
