WHEREAS, the Fire Chief finds it proper and necessary to amend the 2015 Fire Bureau budget, transferring \$29,267.00 from budget line A3410.51000 (Personal Services – Firefighter GR1) to budget line A3410.52600 (equipment); and

WHEREAS, the proposed budget transfer was approved by the Board of Estimate and Apportionment on May 27, 2015; and

WHEREAS, the Council of the City of Binghamton wishes to approve this transfer.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:


