AN ORDINANCE TO AMEND THE 2015
PLANNING DEPARTMENT BUDGET TO
DEFUND THE SUSTAINABLE DEVELOPMENT
PLANNER POSITION AND TO ADD A
PLANNER POSITION

WHEREAS, the Department of Planning, Housing & Community Development (PHCD) wishes to defund the Sustainable Development Planner position in budget line A8684.51000 (Personal Services-Sustainable Development Planner) in the amount of \$39,535 and add a Planner position to budget line A8684.51000 (Personal Services-Planner) in the amount of \$38,495; and

WHEREAS, the Civil Service Commission approved the additional Planner position.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2015 PHCD budget to defund the Sustainable Development Planner position budget line A8684.51000 (Personal Services-Sustainable Development Planner) in the amount of \$39,535 and to add a Planner position to budget line A8684.51000 (Personal Services-Planner) in the amount of \$38,495; and that the remaining difference be transferred to budget line A1990.55000 (Contingency Acct).

Section 2. That this Ordinance shall take effect immediately.

I HEREBY CERTIFY that the above described funds are unencumbered and available.
