AN ORDINANCE AMENDING 2014 BUDGET TO INCLUDE NEW BUDGET LINE A1440.54456 (GENERAL INFRASTRUCTURE IMPROVEMENTS) AND FUND SUCH ACCOUNT WITH A TRANSFER OF \$69,255.08 FROM A9030.58000B (SOCIAL SECURITY) TO COVER THE COST AND CANCELLATION OF THE WASHINGTON ST PROJECT

WHEREAS, the Comptroller has recommended amending the 2014 budget to create a new budget line A1440.54456 (General Infrastructure Improvements) and to fund such account by transferring \$69,255.08 from budget line A9030.58000B (Social Security) to pay for the cost and cancellation of the Washington Street Project; and

WHEREAS, the Board of Estimate and Apportionment approved such amendment and transfer on July 29, 2015.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2014 budget to create a new budget line A1440.54456 (General Infrastructure Improvements) and to fund such account by transferring \$69,255.08 from budget line A9030.58000B (Social Security) to pay for the cost and cancellation of the Washington Street Project.

Section 2. That this Ordinance shall take effect immediately.
