ORDINANCE

**AN ORDINANCE AMENDING THE 2015
BUDGET TO PURCHASE DEMOGRAPHIC
TRACKING SOFTWARE**

WHEREAS, the Mayor and the Chief of Police wish to amend the 2015 budget to transfer \$5,000 from budget line A3120.54114 (Lubricants); \$1,000 from budget line A3120.52200 (Furniture), \$800 from budget line A3120.54111 (Tires), \$2,500 from budget line A3120.54112 (Gasoline/Diesel Fuel), \$1,500 from budget line A3120.54130 (Construction Materials), \$600 from budget line A3120.54520 (Equipment Lease/Rental), \$3,000 from budget line A3120.54610 (Bldg/Equip Repair), and \$5,400 from budget line A3120.54620 (Equip Repairs & Maintenance), for a total of \$19,800, to budget line A1680.52300 (Hardware/Software) to purchase demographic tracking software; and

WHEREAS, the proposed budget transfer was approved by the Board of Estimate and Apportionment on September 2, 2015; and

WHEREAS, Broome County has agreed to pay annual maintenance for the software; and


WHEREAS, the Council of the City of Binghamton wishes to approve these transfers.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2015 budget to transfer \$5,000 from budget line A3120.54114 (Lubricants); \$1,000 from budget line A3120.52200 (Furniture), \$800 from budget line A3120.54111 (Tires), \$2,500 from budget line A3120.54112 (Gasoline/Diesel Fuel), \$1,500 from budget line A3120.54130 (Construction Materials), \$600 from budget line A3120.54520 (Equipment Lease/Rental), \$3,000 from budget line A3120.54610 (Bldg/Equip Repair), and \$5,400 from budget line A3120.54620 (Equip Repairs & Maintenance), for a total of \$19,800, to budget line A1680.52300 (Hardware/Software) to purchase demographic tracking software.

Section 2. That this Ordinance shall take effect immediately.
