AN ORDINANCE AMENDING THE 2015
BUDGET FOR TRANSFERS IN THE GENERAL,
PARKING RAMPS, WATER AND SEWER
FUNDS FOR UNDER BUDGETED SERIAL
BOND PRINCIPAL AND OVER BUDGETED
SERIAL BOND INTEREST

WHEREAS, the Comptroller finds it proper and necessary to make corrections in the various 2015 funds for under budgeted serial bond principal and over budgeted serial bond interest; and

WHEREAS, the proposed budget transfers were approved by the Board of Estimate and Apportionment on September 16, 2015; and

WHEREAS, the Council of the City of Binghamton wishes to approve these transfers.


NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2015 budget as follows:
