AN ORDINANCE AMENDING THE 2015  
BUDGET FOR THE STORM WATER GRANT

WHEREAS, the Comptroller finds it proper and necessary to amend the 2015 budget to increase revenue line A42801 (Interfund Revenue) and to increase expense line A8684.51800 (Planning Temp Labor) both in the amount of \$4,608 to fund administrative expenses of a grant from the Stewart W. and Wilma C. Hoyt Foundation, Inc.; and

WHEREAS, the above revenue is available from budget line H8746.555555.C0033 (Storm Water Grant) which was created pursuant to Permanent Resolution R 13-111, dated December 18, 2013, wherein the City accepted a grant for up to \$48,500.00 from the Stewart W. and Wilma C. Hoyt Foundation, Inc. for a Green Stormwater and Landscaping Matching Fund, including funds for administrative expenses; and


WHEREAS, the proposed budget transfer was approved by the Board of Estimate and Apportionment on September 16, 2015.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2015 budget to increase revenue line A42801 (Interfund Revenue) and to increase expense line A8684.51800 (Planning Temp Labor) both in the amount of \$4,608 to fund administrative expenses of a grant from the Stewart W. and Wilma C. Hoyt Foundation, Inc.

Section 2. That this Ordinance shall take effect immediately.
