AN ORDINANCE AUTHORIZING TRANSFERS
IN THE 2015 ENGINEERING BUDGET TO
FUND OVERTIME

WHEREAS, the Commissioner of Public Works finds it proper and necessary to amend the 2015 Engineering budget to transfer \$20,000 from budget line A1440.51000 (Pers Svcs – Asst City Eng) to budget line A1440.51900 (Overtime) and transfer \$6,675 from budget line A.41289 (Other General Dept Inc) to budget line A1440.51900 (Overtime) to fund overtime; and

WHEREAS, the proposed budget transfers were approved by the Board of Estimate and Apportionment on October 14, 2015; and

WHEREAS, the Council of the City of Binghamton wishes to approve these transfers.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2015 Engineering budget to transfer \$20,000 from budget line A1440.51000 (Pers Svcs – Asst City Eng) to budget line A1440.51900 (Overtime) and transfer \$6,675 from budget line A.41289 (Other General Dept Inc) to budget line A1440.51900 (Overtime) to fund overtime.

Section 2. That this Ordinance shall take effect immediately.
