**AN ORDINANCE AMENDING THE 2019 PARKS  
BUDGET TO DEFUND SR. PARK MAINTAINER  
AND ADD AN ADDITIONAL LABORER**

WHEREAS, the Commissioner of the Parks & Recreation Department and Comptroller of the City of Binghamton find it proper and necessary to amend the 2019 Parks budget to defund Sr. Park Maintainer at an annual salary of \$44,563 and add an additional Laborer at an annual salary of \$37,388; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 12, 2018.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2019 Parks budget to defund Sr. Park Maintainer at an annual salary of \$44,563 and add an additional Laborer at an annual salary of \$37,388, and to transfer funds as follows:

Transfer From (defund/decrease):

\$44,563 A7110.51000 (Per Serv-  
Sr. Park Maintainer)

\$44,563


Transfer To (fund/increase):

\$37,388 A7110.51000 (Per Serv-Laborer)  
7,175 A1990.550004 (Contingency-Parks)

\$44,563
