**AN ORDINANCE AMENDING PERMANENT
ORDINANCE 19-11**

WHEREAS, the Council of the City of Binghamton approved Permanent Ordinance 19-11, dated January 9, 2019, which amended the 2019 Snow Removal budget to create and fund a new budget line for temporary services; and

WHEREAS, the Commissioner of Public Works and the Comptroller find it proper and necessary to declare Permanent Ordinance 19-11 null and void, as the funding is no longer necessary.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2019 Snow Removal budget to declare Permanent Ordinance 19-11 null and void, and to transfer funds as follows:

Transfer From (Decrease):

\$10,000 A5142.51800 (Temp Serv.-CDL Drivers)

Transfer To (Increase):

\$10,000 A5142.51000 (Per Serv.-Snow Removal)

Section 2. That this ordinance shall take effect immediately.
