AN ORDINANCE TO AMEND THE 2019
INSURANCE FUND BUDGET FOR
EMERGENCY REPAIRS TO CITY COUNCIL
CHAMBERS DUE TO AN EXCESSIVE RAIN
EVENT

WHEREAS, the Corporation Counsel and Comptroller of the City of Binghamton find it proper and necessary to amend the 2019 Insurance Fund for emergency repairs to City Council Chambers due to an excessive rain event; and

WHEREAS, this budget transfer was approved by the Board of Estimate and Apportionment on August 7, 2019.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2019 Insurance Fund for emergency repairs to City Council Chambers due to an excessive rain event as follows:

Transfer From (Decrease):

\$15,000 M1910.54430 (Legal Services)
15,000 M1910.54900 (Prov for Incurred
Loss)

\$30,000

Transfer To (Increase):

\$30,000 M1910.54754 (Emergency Safety
Rep/Imp)

\$30,000

Section 2. That this ordinance shall take effect immediately.
