**ORDINANCE**

**AN ORDINANCE TO AMEND THE 2019 WATER  
AND CAPITAL BUDGET TO USE THE WATER  
FUND BALANCE FOR THE HARDING AVENUE  
WATER TANK REPLACEMENT PROJECT**

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2019 Water and Capital Budget to create a new expense line in the Capital Fund and to transfer funds thereto for the Harding Avenue Water Tank Replacement Project; and

WHEREAS, funds are available for this purpose; and

WHEREAS, the budget transfer was approved by the Board of Estimate and Apportionment on August 7, 2019.


NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2019 Water and Capital Budget to create new budget line H8340.525276 (Harding Ave Water Tank Rep) and to transfer funds thereto for the project as follows:

- (i) \$644,000 decrease to budget line FX599 (Appropriated Fund Balance)
- (ii) \$644,000 increase to budget line FX9950.59000 (Transfer to Capital)
- (iii) \$644,000 increase to budget line H.45031 (Interfund Transfer)
- (iv) \$644,000 increase to budget line H8340.525276 (Harding Ave Water Tank Rep)

Section 2. That this ordinance shall take effect immediately.
