
A RESOLUTION AUTHORIZING THE MAYOR

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized into an agreement, approved as to form and content by the Office of Corporation Counsel, with Broome County Urban League for the use of Fiscal Year 39 Community Development Block Grant funds in the total amount of \$16,735.00 and that funds shall be deducted from budget line 8676.533515.CDY39 (Human Services).
