A RESOLUTION AUTHORIZING THE
APPLICATION AND ACCEPTANCE OF A
GRANT FROM THE NEW YORK STATE
LOCAL GOVERNMENT RECORDS
MANAGEMENT IMPROVEMENT FUND

WHEREAS, the City of Binghamton is eligible to receive a grant from the New York State Archives Department of Local Government Records Maintenance Improvement Fund for the City Clerk's Office to digitize and index vital records currently stored on microfilm; and

WHEREAS, there is no required City match; the Deputy City Clerk will be the grant project manager; and the anticipated date of project completion is June 30, 2014; and

WHEREAS, the application requires the approval and endorsement of the governing body of the municipality in which the project will be located.

NOW, THEREFORE, the Council of the City of Binghamton duly convened in regular session, does hereby.

RESOLVE that Council does hereby approve and endorse the application of the City of Binghamton to the New York State Archives Department for a grant in order to digitize and index vital records currently stored on microfilm retained in the City Clerk's Office; and be it further;

RESOLVED there is no required City match, the Deputy City Clerk will be the grant project manager, and the anticipated date of project completion is June 30, 2014; and be it further

RESOVLED that upon approval of said application the Mayor, or his designee, is hereby authorized to enter into and execute an agreement, approved as to form and content by the Office of Corporation Counsel, with the State to accept such grant.
