A RESOLUTION AUTHORIZING THE MAYOR
TO ENTER INTO A CONTRACT WITH
BROOME COUNTY FOR WORK RELATED TO
THE COMMUNITY TRANSFORMATION
GRANT AND ACCEPT UP TO \$5,000

WHEREAS, the City is eligible to receive a \$5,000 grant from Broome County for work related to the Community Transformation Grant; and

WHEREAS, the purpose of the grant is to continue implementation of the City's Complete Street Policy, which supports walkable and livable communities through universal designs that promote physical activity for all ages and abilities; and

WHEREAS, there is no required City match; that, pending reimbursement, funding for the project will be deducted from the General Fund; the Chief Planner will be the grant project manager; and that the anticipated date of project completion is September 29, 2013; and

WHEREAS, the application requires approval and endorsement of the governing body of the municipality in which the project will be located.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE, that the Council of the City of Binghamton does hereby approve and endorse the application of the City of Binghamton for a \$5,000 grant from Broome County for work related to the Community Transformation Grant; and be it further

RESOLVED, that there is no required City match; that, pending reimbursement, funding for the project will be deducted from the General Fund; the Chief Planner will be the grant project manager; and that the anticipated date of project completion is September 29, 2013; and be it further

RESOLVED, that upon approval of said application by the Mayor, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with Broome County to accept and implement such grant.
