

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized into an agreement, approved as to form and content by the Office of Corporation Counsel, with Cornell Cooperative Extension for the use of Fiscal Year 38 Community Development Block Grant funds in the total amount of \$13,899.00 and that funds shall be deducted from budget line CD8525.533525.CDY38 (Youth Programming).
