WHEREAS, the City of Binghamton wishes to commit \$10,000.00 to the Project; and



RESOLVE that the Mayor, or his designee, is authorized to enter into an agreement for the Project, approved as to form and content by the Office of Corporation Counsel, with the Broome County United Way; and be it further

RESOLVED that \$8,534.01 is available from budget line CD8676.533515.CDY36 (Human Services and \$1,465.99 is available from budget line CD8676.533515.CDY37 (Human Services) for the Project.
