WHEREAS, the City of Binghamton wishes to submit a consolidated fund application to the Market New York Grant Program for funding in the total amount of \$75,000 to help promote tourism and market various aspects of the City; and

WHEREAS, the total cost of the project is \$100,000, with a \$10,000 local match and \$15,000 from various partners; the grant project manager will be the Director of Economic Development; and the anticipated date of project completion is December 31, 2015; and

WHEREAS, funding for such local match is available from budget line A6989.54742 (Marketing).

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Council of the City of Binghamton does hereby approve and endorse a grant application in the amount of \$75,000 under the market New York Grant Program to help promote tourism and market various aspects of the City; and be it further

RESOLVED that the total cost of the project is \$100,000, with a \$10,000 local match and \$15,000 from various partners; the grant project manager will be the Director of Economic Development; and the anticipated date of project completion is December 31, 2015; and be it further


RESOLVED funding for such local match is available from budget line A6989.54742 (Marketing); and be it further
