WHEREAS, the Council of the City of Binghamton adopted Permanent Resolution 14-4 on February 5, 2014 entitled, "A Resolution Authorizing an Application to the New York State Local Government Records Improvement Fund"; and

WHEREAS, the City of Binghamton was awarded \$9,310 from the New York State Archives Local Government Improvement Fund Grant; and


WHEREAS, there is no required City match, the City of Binghamton's City Clerk shall be the grant project manager, and the anticipated date of project completion is June 30, 2015.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE, that the Mayor of the City of Binghamton, or his designee, is authorized to execute a project agreement, approved as to form and content by the Office of Corporation Counsel, to carry out and comply with the terms of such project agreement and to accept grant funds of \$9,310 from the New York State Local Government Records Management Improvement Grant; and be it further

RESOLVED that there is no required City match, the City of Binghamton's City Clerk shall be the grant project manager, and the anticipated date of project completion is June 30, 2015.
