WHEREAS, the Director of Parks and Recreation has recommended entering into an agreement with Palumbo Group for design services to upgrade the bath houses at Cheri Lindsey Park and Webster Street Park at a cost not to exceed \$28,900; and

WHEREAS, funding is available from budget line H7110.525126.40914 (Upgrade Pool Bathhouse Design).

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE, that the Mayor, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with Palumbo Group for design services to upgrade the bath houses at Cheri Lindsey Park and Webster Street Park at a cost not to exceed \$28,900; and be it further


RESOLVED that funding is available from budget line H7110.525126.40914 (Upgrade Pool Bathhouse Design).
