A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH NEW YORK STATE OFFICE OF PARKS, RECREATION AND HISTORIC PRESERVATION FOR A \$500,000 GRANT FOR THE OURSPACE PROJECT AT RECREATION PARK, PROJECT NO. 148647

WHEREAS, the New York State Office of Parks, Recreation, and Historic Preservation approved a grant to *Life is... Washable* in the amount of \$500,000 for the Our Space at Recreation Park Project EPF/CFA 148647, City of Binghamton, Broome County, 14PR04555; and

WHEREAS, the City of Binghamton wishes to accept assignment of said grant from *Life is... Washable*; and

WHEREAS, there are specific requirements and regulations governing the expenditure of these funds; and

WHEREAS, City of Binghamton wishes to authorize the Mayor to accept said grant; and

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the City of Binghamton hereby accepts assignment of the New York State Office of Parks, Recreation, and Historic Preservation grant in the amount of \$500,000 for the Our Space at Recreation Park Project EPF/CFA 148647, City of Binghamton, Broome County, 14PR04555 from *Life is... Washable*; and it is further

RESOLVED that the administration of all funds under this grant will be in accordance with all terms and conditions contained in the rules and regulations of Article 54, Title 9 of the Environmental Protection Fund; and it is further

RESOLVED that Richard C. David, as Mayor of the City of Binghamton, is hereby authorized and directed to accept funds from the New York State Office of Parks, Recreation, and Historic Preservation in accordance with the provisions of Title 9 of the Environmental Protection Act of 1993, in an amount not to exceed \$500,000, and enter into and execute a project agreement with the State for such financial assistance to the City of Binghamton for the Our Space at Recreation Park Project.
