WHEREAS, the City of Binghamton is provided miscellaneous information technology (IT) services by the Broome County Division of Information Technology pursuant to the Broome County IT Services Catalog; and

WHEREAS, the City of Binghamton wishes to define and codify service expectations for maintenance and support provided by the Broome County Division of Information Technology; and

WHEREAS, the Council of the City of Binghamton wishes to authorize the Mayor to enter into an agreement with Broome County for the term of January 1, 2015, through December 31, 2015; and

WHEREAS, funds to pay for such IT services are available from budget line A1680.54630 (Information & Management Technology HW/SW Maintenance).

NOW, THEREFORE, the Council of the City of Binghamton duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with Broome County for IT services for the term of January 1, 2015, through December 31, 2015; and that funds to pay for such IT services are available from budget line A1680.54630 (Information & Management Technology HW/SW Maintenance).
