WHEREAS the City wishes to enter into an agreement with CNY Fair Housing, Inc. to develop an AI at a cost not to exceed \$18,900.00; and



RESOLVE that the Mayor, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with CNY Fair Housing, Inc. to develop an AI at a cost not to exceed \$18,900.00; and be it further
