WHEREAS, the City of Binghamton wishes to submit a grant application to Empire State Development for development of a City Parks and Recreation Master Plan in the amount of \$25,000; and

WHEREAS, the grant project manager is the Commissioner of Parks and Recreation, the project is anticipated to be completed in December 2016, there is a local match of \$25,000, which is anticipated to be available in 2016 budget; and

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE, that the Council of the City of Binghamton does hereby approve and endorse a grant application to Empire State Development for development of a City Parks and Recreation Master Plan in the amount of \$25,000; and be it further
