**A RESOLUTION AUTHORIZING THE MAYOR
TO ENTER INTO AN AGREEMENT WITH GHD
CONSULTANTS TO COMPLETE WORK
ORDER #6 FOR THE BAF RESTORATION AND
REHABILITATION PROJECT AT THE JSTP**

WHEREAS, the City of Binghamton is a joint owner of the Binghamton-Johnson City Joint Sewage Treatment Plant (JSTP) with the Village of Johnson City; and

WHEREAS, the Commissioner of Public Works has recommended that the City enter into a professional services agreement with GHD for engineering consulting services for the restoration and rehabilitation of the JSTP at a cost not to exceed \$5,934,000.00, as described in the attached proposal; and

WHEREAS, funds are available from budget line HX8150.500100.J1NN (Professional Services –Non Flood).

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with GHD for engineering consulting services for the restoration and rehabilitation of the BJCJSTP at a cost not to exceed \$5,934,000.00, as described in the attached proposal; and be it further

RESOLVED that such funds shall be deducted from budget line HX8150.500100.J1NN (Professional Services –Non Flood); and be it further

RESOLVED that this Resolution shall be effective upon approval of the Board of Trustees of the Village of Johnson City.
