A RESOLUTION AMENDING PERMANENT RESOLUTION R15-38 TO CHANGE THE FUNDING SOURCES FOR THE AGREEMENT WITH MCFARLAND JOHNSON TO PROVIDE DESIGN SERVICES TO UPGRADE THE HEATING/COOLING SYSTEM (HVAC) AT FIRST WARD SENIOR CENTER

WHEREAS, Permanent Resolution R15-38, entitled, "A Resolution Authorizing the Mayor to Enter into an Agreement with McFarland Johnson for Electrical Design for Various Projects, Not to Exceed \$50,000" identified the funding sources for said agreement as \$26,000.00 from budget line H8120.525055.40914 (Repl Sewer Lines) and \$24,000.00 from budget line H8340.525058.40914 (Water Lines); and

WHEREAS, the City wishes to amend the funding sources for Permanent Resolution R15-38 to include \$20,000 from budget line H7620.525122.40914 (First Ward Center - Heating Cooling) to provide design services to upgrade the heating/cooling system (HVAC) at First Ward Senior Center and to reduce the other funding sources accordingly.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that Permanent Resolution R15-38 is hereby amended to delete the second "Resolved" paragraph and is replaced as follows:

RESOLVED that funds in the amount of \$20,000.00 will be deducted from budget line H7620.525122.40914 (First Ward Center - Heating Cooling), \$16,000.00 will be deducted from budget line H8120.525055.40914 (Repl Sewer Lines) and \$14,000.00 from budget line H8340.525058.40914 (Water Lines); and be it further

RESOLVED that the purpose of the above amendment is to provide design services to upgrade the heating/cooling system (HVAC) at First Ward Senior Center.

I HEREBY CERTIFY that the above described funds are unencumbered and available.
