
A RESOLUTION AUTHORIZING THE MAYOR
TO ENTER INTO AN AGREEMENT WITH
WLADIS LAW FIRM FOR GRANT
CONSULTING SERVICES

WHEREAS, the City of Binghamton wishes to enter into a renewal agreement with Wladis Law Firm for grant consulting services in an amount not to exceed \$65,000 for a one (1) year term expiring on December 31, 2016, with the City's option to renew in an amount not to exceed \$65,000 for an additional one (1) year term through December 31, 2017.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with Wladis Law Firm for grant consulting services in an amount not to exceed \$65,000 for a one (1) year term expiring on December 31, 2016, with the City's option to renew in an amount not to exceed \$65,000 for an additional one (1) year term through December 31, 2017, and that funding for such agreement shall be deducted from budget line A6989.54410 (Professional Services).
