
A RESOLUTION AUTHORIZING THE MAYOR
TO ENTER INTO AN AGREEMENT WITH
CATHOLIC CHARITIES OF BROOME COUNTY
FOR THE USE OF FEDERAL FISCAL YEAR 41
ESG FUNDING IN AN AMOUNT NOT TO
EXCEED \$37,500

WHEREAS, the City of Binghamton wishes to enter into an agreement with CATHOLIC CHARITIES OF BROOME COUNTY for the use of Federal Fiscal Year 41 Emergency Shelter Grant ("ESG") funding in an amount not to exceed \$37,500.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized into an agreement, approved as to form and content by the Office of Corporation Counsel, with CATHOLIC CHARITIES OF BROOME COUNTY for the use of Federal Fiscal Year 41 Emergency Shelter Grant funds in the total amount of \$37,500 and that funds shall be deducted from budget line CD6142.533550.CDY41 (ESG – Program Funds).
