**A RESOLUTION AMENDING THE 2015
BUDGET TO ADJUST ACCOUNTS THAT WILL
BE OVER BUDGET FROM ACCOUNTS THAT
WILL BE UNDER BUDGET**

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2015 Parking Ramps budget to make year-end adjustments to pay for insurance, management services, and debt principal – serial bonds; from gas-heat, debt principal BANS, and debt interest – serial bonds, for a total transfer of \$55,730.13; and

WHEREAS, the proposed budget amendments were approved by the Board of Estimate and Apportionment on January 13, 2016; and


WHEREAS, the Council of the City of Binghamton wishes to approve these amendments.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2015 Parking Ramps budget to (i) increase budget lines CP5650.54300 (Insurance) in the amount of \$15,000.00, CP5650.54427 (Mang't Services) in the amount of \$36,500.00, and CP9710.56000 (Debt Prin.-Serial Bonds) in the amount of \$4,230.13; and (ii) decrease budget lines CP5650.54201 (Gas-Heat) in the amount of \$15,000.00, CP9730.56000 (Debt Prin.-BANS) in the amount of \$17,957.00, and CP9710.57000 (Debt Inst.-Serial Bonds) in the amount of \$22,773.13; for a total transfer of \$55,730.13.

Section 2. That this Ordinance shall take effect immediately.


