**A RESOLUTION TO EXTEND THE TIME  
FRAME OF THE SAFER GRANT AWARDED TO  
THE CITY OF BINGHAMTON IN 2014**

WHEREAS, the Council of the City of Binghamton passed Permanent Resolution R14-18 on April 9, 2014 to accept the New York State SAFER Grant to hire eight Firefighter positions; and

WHEREAS, these funds are set to expire on June 15, 2016, and a balance of \$276,459.66 will be remaining; and

WHEREAS, New York State will allow the Fire Department to apply for an amendment to use those remaining funds to extend the grant through October 31, 2016; and

WHEREAS, the Fire Chief of the City of Binghamton is requesting approval to amend the grant and use the remaining funds to continue funding the eight Firefighter positions until October 31, 2016; and

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to execute any and all documents, approved as to form and content by the Office of Corporation Counsel, to amend the New York State SAFER grant and use the remaining funds to fund eight Firefighters through October 31, 2016.
