**A RESOLUTION AUTHORIZING THE MAYOR  
TO ENTER INTO AN AGREEMENT WITH ENV

PROFESSIONAL LIABILITY INSURANCE**

WHEREAS, the City of Binghamton Fire Bureau ("the City") operates an ambulance service; and

WHEREAS, the City is generally self-insured for all liability; and

WHEREAS, in an effort to minimize the City's loss exposure, the City has received proposals from various insurance providers for EMT/Ambulance Professional Liability Insurance; and


WHEREAS, the proposal from ENV Property and Casualty, LLC (Lloyds of London), at a cost not to exceed \$21,056, has been determined to meet the City's needs; and

WHEREAS, funds are available from budget line A3410.54300 (Insurance) for this purpose.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to enter into an agreement with ENV Property and Casualty, LLC (Lloyds of London), approved as to form and content by the Office of Corporation Counsel, for EMT/Ambulance Professional Liability Insurance at a cost not to exceed \$21,056, and that funding for such insurance shall be deducted from budget line A3410.54300 (Insurance).
