RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized into an agreement, approved as to form and content by the Office of Corporation Counsel, with Volunteers of America for the use of unspent older Emergency Shelter Grant ("ESG") funding in an amount not to exceed \$37,000 and that funds shall be deducted from budget line CG6142.533999.CGY41 (ESG – Sunset).
