\$8,000 TO INSTALL DUCTLESS AIR-
CONDITIONERS AT ITS MEN'S SHELTER

WHEREAS, the City wishes to enter into an agreement with Volunteers of America for use of Fiscal Year 44 Emergency Shelter Grant ("ESG") funds in an amount not to exceed \$8,000 to install ductless air-conditioners at its Men's Shelter;

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with Volunteers of America for the use of Fiscal Year 44 Emergency Shelter Grant funds in the total amount of \$8,000 to install ductless air-conditioners at its Men's Shelter and that funds shall be deducted from budget line CG6142.533550.CGY44 (ESG – Program Funds) for this purpose.
