A RESOLUTION AUTHORIZING THE MAYOR
TO ACCEPT A GRANT FROM THE UNITED
STATES TENNIS ASSOCIATION (USTA) FOR
TENNIS-RELATED EXPENSES ASSOCIATED
WITH REOPENING OF FACILITIES IN 2020

WHEREAS, the City of Binghamton is eligible to receive a grant in the amount of \$3,000 from the United States Tennis Association ("USTA") for tennis-related expenses associated with reopening of facilities in 2020; and

WHEREAS, the grant does not require a local match, that the grant will be administered by the Commissioner of Parks and Recreation, or his designee, and that the estimated date of completion is December 2020.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to execute any and all documents, approved as to form and content by the Office of Corporation Counsel, to accept a grant in the amount of \$3,000 from the USTA for tennis-related expenses associated with reopening of facilities in 2020; and that the Comptroller is authorized to amend the budget accordingly; and be it further

RESOLVED that grant does not require a local match, that the grant will be administered by the Commissioner of Parks and Recreation, or his designee, and that the estimated date of completion is December of 2020.
